

1. Promotion

The terms and conditions defined below (hereinafter referred to as the "**Terms**") constitute the rules of a promotion offered by Raw Trading Ltd (IC Markets Global) (hereinafter referred to as "**we**", "**our company**", "**our platform**" , broker license number: SD018). Under these terms, customers (hereinafter referred to as "**you**", "**your**", "**new customer**") can get a New Year bonus opportunity (hereinafter referred to as "**Promotion**") after meeting the minimum initial deposit and minimum trading volume requirements of the Promotion.

2. Eligibility criteria for new customers

The Promotion opportunity is only applicable if the new customer meets the following eligibility criteria:

Eligible new customers must:

- 1) be eligible to open an account with the Company;
- 2) be a resident of Thailand, Vietnam, Indonesia, Singapore, Philippines, Laos or Brunei Darussalam, and the account is regulated by the Financial Services Authority of Seychelles (FSA). This geographic restriction is due to the targeted nature of this marketing campaign;
- 3) be of legal age in your jurisdiction;
- 4) have never made a first deposit on the platform before the Promotion starts;
- 5) Meet the net deposit and minimum trading volume requirements specified in Clause 4.2 during the Promotion Period (as defined below) ;
- 6) Have no unresolved trading disputes, account suspensions, or breaches of the Company's trading rules, policies, or applicable terms and conditions during the Promotion Period (as defined below);
- 7) Agree to and comply with these Terms and all other legal documents applicable to their trading account. Participation does not constitute investment advice or a recommendation to trade.

3. Promotion period

The Promotion period is from **January 26, 2026 to March 31, 2026 (Beijing time)**, unless we terminate this Promotion in accordance with clause 6.13 (hereinafter referred to as the "Promotion Period") and termination will not affect participants who have already fulfilled qualification requirements, except in cases involving fraud, abuse or regulatory obligation.

4. How to participate

4.1 For new customers who want to participate in this Promotion, you need to open a live trading account with IC Markets Global (if you do not have one before the start of this Promotion);

4.2 New customers will only receive a chance to participate in the Promotion if they meet all of the following qualifying criteria:

- a) Minimum deposit - New customers need to make an initial deposit of at least \$200 (or equivalent amount in the account base currency) in their live account during the promotion period*;

b) Minimum trading volume - New customers need to complete at least 2 valid standard lots before March 31, 2026*, and the trading products are limited to foreign exchange and/or precious metals. Trading volume requirements relate solely to bonus qualification and do not encourage or advise trading activity.

* The deposit amount within the Promotion period is calculated according to the total net deposit amount (net deposit=deposit-withdrawal).

*Qualifying trades are defined as closed trades with an open duration of at least 5 minutes. There is no limit on the amount of a single trade. However, hedging trades will not be counted as qualifying trades. Trades closed due to margin calls or forced liquidations will not qualify. Artificial trading behaviour, including but not limited to latency arbitrage, wash trading, back-to-back offsetting, coordinated hedge grids or any activity designed solely to generate trading volume, will not qualify.

For the avoidance of doubt, the minimum deposit and trading volume requirements must both be met to have you entitled to the Promotion bonus.

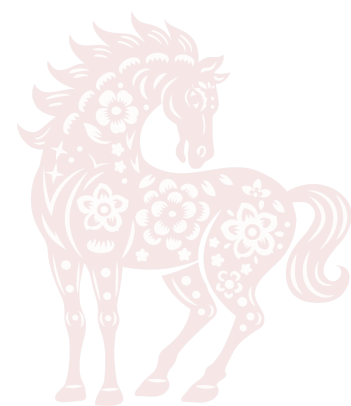
5. Promotion Draw Rules

5.1 Once a new client meets the minimum deposit and minimum trading volume requirements as stipulated in Clause 4.2, a prize draw link will be sent to the registered email address of the eligible client within 20 business days after the event ends. The prize pool for this Promotion is set according to the participant's deposit and trading level, and the corresponding rewards are as follows:

- 5.2 The New Year bonus for this Promotion will be awarded according to the prize draw results. The event bonus will be deposited in the form of bonus to the trading account filled in when registering. The bonus can be used for withdrawal or for MT4, MT5 or cTrader transactions. The event rewards will not be paid in other forms. The Company reserves the right to conduct enhanced due diligence, request proof of source of funds, and verify client identity prior to approving any bonus withdrawal.
- 5.3 You must fill in the Promotion registration form through the event page before March 31, 2026. Failure to fill in the registration form during the event period will be deemed as giving up.

6. Other Terms and Conditions

- 6.1 This Promotion cannot be participated in conjunction with other marketing promotions offered by us, unless otherwise stated in the terms of that Promotion;
- 6.2 By joining this Promotion, you agree and accept to comply with these Terms and all relevant terms and conditions applicable to your trade accounts with us;
- 6.3 Each client may participate in this Promotion only once;
- 6.4 Multiple accounts held by the same client will be treated as a single participation in this Promotion;
- 6.5 For the avoidance of doubt, joint accounts will be regarded as one client under this Promotion;
- 6.6 The deposit amount during the Promotion Period is calculated based on the total net deposit amount (Net Deposit = Total Deposits - Total Withdrawals). Deposits made via rebate transfers, internal transfers (including transfers between trading accounts or IC profiles belonging to the same client), or other non-bank external transfers will not qualify as eligible deposits under this Promotion. Only deposits made directly from the client's external bank account or payment method will be considered valid. The Company reserves the right to request proof of deposit source at its discretion;
- 6.7 You are responsible for any tax consequences, if any, that may result from your participation in this Promotion and the Company will not withhold taxes;
- 6.8 Trading Forex and CFDs carries risks and may not be suitable for all investors. Losses might exceed your original investment. Before you decide to join this Promotion and invest with us, please ensure you have fully read all legal documents applicable to your trade account and are fully aware of the risk contained. You may obtain a copy of these legal documents from our website. Seek independent advice if necessary;
- 6.9 We shall not assume any liability for any losses incurred to any clients in connection with the Promotion, however arising, including but not limited to losses incurred from trading. The clients participate at their own risk;
- 6.10 We reserve the right to revoke any bonus credits and/or disqualify participants if any form of abuse, fraud, manipulation, or exploitation related to this Promotion is detected. This includes, but is not limited to, wash trading, coordinated trading between multiple accounts (whether under the same or different client profiles), artificial trading activity designed to generate volume, or any behavior that, indicates a lack of genuine trading intention. Decisions will be based on reasonable evidence of abusive or suspicious activity. In such cases, the Company may cancel, reclaim, or adjust any bonus credits or profits derived therefrom without prior notice.;

- 6.11 Any violation of these Terms might lead to the bonus credits being cancelled, or claimed back, as applicable and at our sole discretion;
- 6.12 If any client is discovered to be ineligible for the Promotion for any reason, we are entitled to at any time:
 - (i) Forfeit, withdraw or withhold the bonus credits;
 - (ii) Or where the bonus credit has been awarded and/or utilised, reclaim the bonus credit and/or deduct the utilized portion of the bonus credits from the client’s account.

In such an event, no person shall be entitled to any payment or compensation from us;
- 6.13 We may, at our discretion, vary, amend, delete and/or add on to any of the terms, including, but not limited to, terminating this Promotion at any time without giving any reason or prior notice or assuming any liability to any client(s), and all client(s) shall be bound by such variations, amendments, deletions and/or additions. Material changes will not adversely affect participants who have already met qualification criteria, except in cases involving fraud, breach of terms or regulatory requirements.
- 6.14 We shall be the sole determiner of the interpretation of these Terms and we will act reasonably and in good faith when interpreting these Terms;
- 6.15 To the maximum extent permitted by law, all participants agree to keep us indemnified at all times against any liability, claims, demands, losses, damages, costs, and expenses resulting from or in connection with this Promotion. Participants shall indemnify the Company only for losses arising from their breach of these Terms or fraudulent conduct.
- 6.16 If any provision(s) of this Terms is held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect;
- 6.17 Our decision in any matter in relation to this Promotion will be final and conclusive, provided such decisions are made reasonably and in compliance with applicable law;
- 6.18 Our employees or other producers or suppliers associated with this Promotion, their advertising, printing and publicity agencies, and their immediate family members (i.e. any person residing in the household of the aforementioned people) will not be eligible to participate in the Promotion.
- 6.19 The Terms shall be governed by and construed in accordance with the laws of Seychelles.
- 6.20 Personal data collected for this Promotion will be processed in accordance with our Privacy Policy and the Seychelles Data Protection Act.
- 6.21 In the event of any inconsistency between these Terms and the Client Agreement, these Terms shall prevail solely in relation to the Promotion.
- 6.22 The English version of this Promotion shall be the sole binding version. In the event of any inconsistency or discrepancy between the English version and any translated version, the English version shall prevail.
